



## **Breckenridge Resort Chamber Event Vendor Rules and Regulations**

The Breckenridge Resort Chamber (BRC) holds various events throughout the year. Vendors interested in participating in any BRC event are required to read, sign and submit a “Vendor Rules and Regulations” form.

### **Expectations**

Vendors are expected to attend all the events they commit to. If there are health reasons or an emergency preventing you from attending the specific event, please make every effort to contact Sandy Metzger, BRC Events Director, as soon as possible at (970) 453-5074. A vendor that is a no show/no call is not acceptable nor is it fair to other vendors as it disrupts the carefully planned layout and appearance of the event.

- All vendors need to be set up and ready to go by the time specified for a particular event by the BRC - no exceptions.
- All vendors are expected to stay for the duration of the event even if your product has sold out.
- Vehicles are strictly prohibited through the pedestrian zones of an event during the hours of the event.

### **Vendors**

Participating vendors must pay all BRC event fees (i.e. booth fee, BRC Membership fee) prior to the start of the event.

All vendors must obtain permission to participate in a BRC event prior to the start of the event; location placement will be assigned by the BRC.

Vendors are ambassadors of each event and shall act accordingly. Customer service is of the utmost importance to the BRC and to our guests. Poor customer service or complaints thereof will result in the review of a vendor’s ability to participate in future events.

### **Product Standards**

The BRC Event Director and/or Coordinator reserve the right to reject any product that is similar to an existing vendor’s product or that of a neighboring merchant, is not of marketable quality or that is deemed inappropriate for the event. If it is a food item that is being sold, it must have proper licensing from the Summit County Environmental Health authorities and the State, if applicable.

### **Cleanliness**

Each vendor is responsible for ensuring the cleanliness of his or her area, especially at the conclusion of each event day. The Town of Breckenridge provides lined trash cans throughout the event for the general public. Vendors are expected to pack out heavy product, packing materials or mass amounts of product. IF you would like corrugated cardboard boxes recycled, please speak with the Event Director or Coordinator at the onset of the event. Failure to leave the venue in a clean and orderly fashion will result in a warning and in the review of a vendor’s ability to participate in future events.

**Taxes**

Each event vendor is responsible for the collection and payment of his or her Breckenridge/Summit County/State of Colorado (if applicable) taxes. All taxes are paid to the State of Colorado. There will be event tax forms supplied upon registration and acceptance of participation in an event. You will need to fill it out and submit it to the Town with your Breckenridge sales Tax. The County and State taxes are remitted to the State with a small fee.

Below is a list of all tax responsibilities for all food and non-food sales within the Town of Breckenridge town limits:

- 2.5% Town of Breckenridge
- 2.75% Summit County
- .125% Summit Combined Housing Authority
- 2.9% State of Colorado

The BRC shall use its best efforts to conduct and promote all events to assure the largest possible attendance.

Each party represents and warrants that it is free to enter into this Agreement without violating the rights of any person, that its trademarks do not infringe on the trademarks or trade names of any other person, and that it will comply with all laws and regulations pertinent to its business.

This agreement does not constitute a partnership or joint venture or principle-agent relationship between the BRC and the vendor. The Agreement may not be assigned by either party. It shall be governed by the laws of the State of Colorado. It is complete and represents the entire agreement between the parties.
